Election Rules and Regulations of National Neonatology Forum, India

- Only eligible members of the Society shall be eligible to offer themselves as candidates for elections or to propose or second the candidature of any member or participate in voting at the election.
- Candidate shall be a life-member of NNF for more than Ten completed years.
- The candidate for President elect shall have submitted his/her accounts pertaining to any of the projects/Program of NNF before filing his/her nomination or propose or second the candidature of any members, as the case maybe.
- The election of the President Elect of the society shall be by secret ballot.
- Term of the office as President-Elect shall be for 2018. He /She shall take over as President of NNF for the year 2019. Nomination shall be duly proposed and seconded by eligible member of the society and consented to by the candidate concerned. All the particulars contained in the Nomination Paper should be correctly filled up as per record.
- Nomination Paper duly filled in, signed and addressed to Returning Officer should reach NNF Office not later than 5.00 p.m. on 22nd January, 2018. Faxed/emailed nomination papers will be treated as "Invalid".
- As per Approval of Governing Body Members, Dr. G.P. Kaushal to continue as Election Officer to conduct this election for the vacant post of President-Elect 2018 (President-2019).
- Any member who has any complaint about the election shall give the same in writing addressed to Secretary within 21 days of the declaration of results. An election tribunal nominated by the Governing Body shall go into the complaints and the decision of the tribunal shall be final. In case a member of the tribunal be involved himself in any way in such a dispute, he shall not be a member of the tribunal.
