Position: Neonatology Departmental Fellow

June 30, 2026

This job is a contract position working primarily in the Neonatal Intensive Care Unit (NICU). The neonatal coverage will also include some coverage in the Level I nursery and Paediatric Ambulatory Clinic. The departmental fellow will be expected to also provide Labour and Delivery Room/Neonatal Resuscitation coverage, as well as on call coverage under the supervision of an attending staff Neonatologist. A month elective can be arranged for antenatal consultations, neonatal follow-up or other area of research or clinical interest.

#### **Weekday Clinical Coverage Requirements:**

Each fellow is expected to provide daily clinical service from Monday to Friday in the designated unit <u>except</u> on the days where the fellow has not been scheduled to work and weekdays following a 16-hour or 24-hour on-call shift.

#### On-Call Coverage requirements:

On-call coverage will be in the form of 8-hour, 16-hour or 24-hour shifts. Each fellow will provide on-call clinical services up to a total of 1408 hours covering one of the in-house on-call positions.

To Whom It May Concern;

I would like to thank you for your interest in the Neonatology Departmental Fellowship at Mount Sinai Hospital. We have available positions for the academic year 2025-2026, starting July 1<sup>st</sup>, 2025.

Mount Sinai Hospital has world recognition for its commitment to excellent medicine, teaching and research. Neonatal care is provided at Mount Sinai Hospital through a 62-bed single room design mixed acuity Neonatal Intensive Care Unit (NICU), a Level I nursery, a Neonatal Follow up Clinic and a Paediatric Ambulatory Clinic. The Labour and Delivery department averages 7500 deliveries per year and the NICU has over 1100 admissions. About 300 of these admissions are for newborns less than 1500g. The number of admission and turnover of patients facilitate the exposure to multiple neonatal diagnoses for the training of physicians. Our proximity to the Hospital for Sick children makes us a dedicated hospital for deliveries of patients with complex congenital anomalies: the NICU team at Mount Sinai Hospital has developed a tremendous expertise in the resuscitation of such newborns. All of this has created an excellent opportunity for physicians requiring additional clinical training in neonatology.

The Department of Paediatrics is led by world-renown researcher, Dr. Prakeshkumar Shah as Interim Chief of Paediatrics. This department has 15 neonatologists on staff to cover the different lines of service. Because of its patient population, the NICU at Mount Sinai Hospital generates a tremendous amount of research that centers on clinical epidemiology and outcome research. Many departmental fellows have been able to participate in various research projects during their time at Mount Sinai Hospital.

You will find attached to this letter a summary of the job description for departmental fellows in the Department of Paediatrics at Mount Sinai Hospital. Most departmental fellows are hired for one year but depending on availability of positions and the fellow's performance, a second year may be possible.

  - Although the letterhead on the application form says "Hospital for Sick Children", these Neonatology Departmental Fellowship positions will be based at Mount Sinai Hospital. The Department of Paediatrics at the University of Toronto is housed at the Hospital for Sick Children and is responsible for processing all the applications.
- Clinical skills questionnaire (attached to this e-mail).
  - o This will help us assess your level of skills in the NICU.
- A copy of your medical degree (translated, if not in English or French)
- A copy of your subspecialty certificate (translated, if not in English or French). We will <u>not</u> process any application without this certificate. This document is essential to ensure that the applicant can be licensed through medical authorities in Ontario. If the College of Physicians and Surgeons of Ontario does not accept this certificate, then the application process will stop.

Please be aware that medical degrees issued in Latin language do not require translation. However, any other supporting documents not written in the English or French language must be accompanied by English or French translations. All translations must be certified by one of the following:

- www.physiciansapply.ca (using the Translation Bureau of Public Works and Government Services Canada);
- A Certified Member of the Association of Translators and Interpreters of Ontario;
- To find a certified translator visit https://atio.on.ca/;
- Translations completed by a certified member of the equivalent Association of Translators and Interpreters in another Canadian province/territory;
- A Canadian Embassy overseas or a foreign embassy or consular office in Canada authorized to certify translations;
- Translations sent by the medical school must be dated and stamped by the medical school to verify the contents and received directly from the medical school with a copy of the original language document;

Translated documents are required for the application to Mount Sinai Hospital Neonatology Departmental Fellowship.

Applications that are missing any of the required documents will not be processed. Application files that are complete will be reviewed by a selection committee and you will be contacted for an interview if you are short-listed by the selection committee. We are aware that some applicants may not be able to attend an interview in person and we will therefore allow telephone interviews to facilitate this process.



 Please forward all required documents by August 20, 2024. The remaining available positions will be awarded during the fall 2024.
